## **JOB DESCRIPTION:**

The position will report to the Law Enforcement Academy Director/Chief of Police for job responsibilities and other College related activities as outlined in the Policies and Procedures Manual. Essential duties include but are not limited to the following:

#### **Instructor Duties**

- Obtain/maintain approval as a safety trainer through NCCER, OSHA, NSC, and other training sponsors as needed:
- Deliver risk management and safety courses on a variety of topics, including courses designed to prevent the top injuries for workers in East Texas;
- Spend a minimum of 40 hours per week on campus or at off-campus teaching sites to meet the teaching schedule, divisional needs, and student needs;
- Maintain student training records and comply with training standards as required by NCCER, OSHA and other training sponsors;
- Follow a course syllabus for each course offered and develop and update syllabi as needed to meet requirements of training sponsors and the College;
- Submit class attendance rosters and grades to Workforce & Continuing Education at the end of each course;
- Provide students with access to end-of-course evaluations after each course;
- Provide accommodations to students with disabilities as directed by Student Affairs;
- Submit any required college reports and forms in a timely manner;
- Participate in annual professional development to enhance the content and quality of instruction;
- Collaborate with other campus employees assigned to risk management to schedule training for the campus and region;
- Collaborate with representatives of workforce education programs to schedule OSHA training for students;
- Assist in scheduling law enforcement training as well as risk management and safety courses to be taught throughout the service area of the College;
- Participate in unit planning and assessment for continuous improvement processes;
- Attend scheduled faculty meetings, division meetings and committee meetings;
- Assist in recruitment and retention of students as appropriate;
- Advance the mission of the College through actions in instructional settings, with colleagues, and in the community; and
- Assist with law enforcement in-service training as well as the new licensing training.

# **Law Enforcement Officer Duties**

- Responsible for the protection and security of all College property;
- Enforce regulations concerning parking, blocking or impeding traffic flow;
- Investigate criminal and non-criminal complaints and incidents against persons and property;
- Process crime scenes;
- Make needed contact with defendant and complainants;
- Subdue violent, dangerous or disruptive persons and take appropriate action such as arresting, removing them from campus, or referring them for administrative action;
- Testify and make case presentations in Grand Juries, courts, and other venues as necessary;
- Write reports, parking citations, daily activity logs, and related legal and administrative reports, including Cleary reporting data;
- Assist in preparing annual reports required by the Texas Commission on Law Enforcement, annual campus safety report, and the annual report for the Cleary Act;
- Network with municipal, county, and other law enforcement agencies and prosecutor's offices within the college service area;
- Attend meetings and successfully complete training sessions to satisfy all police officer requirements;
- Provide Law Enforcement duties and Security actions for special events;
- Participate in appropriate professional development for campus police officers;
- Provide presence and maintain the peace at all campus events;
- Assist residence life staff with problematic dorm activity;
- Develop ideas and recommend solutions related to campus safety and law enforcement related activities;
- Periodically unlock building doors for individuals and provide access for event activity;
- Report maintenance issues, security deficiencies, and hazardous conditions that appear across campus;
- Complete daily, monthly, overtime, and special event logs and time and attendance record; and
- Provide assistance with training in the day and night classes for the Law Enforcement Academy under the direction of a training manager or Academy Director as needed.
